### **OLD BUSINESS:**

A. HAUSMAN ROAD BRIDGE ALTERNATE OPTION - Doug Hedrick provided literature from Keystone Concrete Products and recommended the BOS consider precast box culvert bridge options for Hausman Road bridge. This option should be much less expensive than the other alternative. Re-visit in early 2020 when the final PennDOT inspection report is received.

- A. MCPC PLANNING ASSISTANCE CONTRACT Tabled until December 4th meeting for Solicitor review.
- **B. VERIZON FIOS FRANCHISE RENEWAL** Correspondence received from Verizon regarding the expiration of the cable television franchise on June 28, 2022. Solicitor advised future correspondence will be sent for renewal.
- **C. Proposed Ordinance** #180 Solicitor reported and provided draft proposed ordinance amending section 1200N of zoning ordinance. Motion 19-135 by Lynch, second by Baker and Myers authorizing Solicitor to advertise and begin 30 day review period. Motion carried 3 0. Adoption expected December 23, 2019.
