ANNOUNCEMENT OF EXECUTIVE SESSION – Barb Lynch reported executive session was held Friday, June 9th on real estate matters.

PUBLIC HEARING - ORDINANCE #176 - Township Solicitor Stephen Imms opened the public hearing to adopt proposed ordinance #176 amending Article 14 of zoning ordinance. Solicitor marked exhibits - proof of publication and review letters. Solicitor called for public comment and confirmed with Barb McMonagle (PC Chair) the amendment is consistent with planning commission recommendation - the public hearing was closed. **Motion 17-083** by Styer, second by Lynch approved adoption of Ordinance #176. Motion carried 2 - 0.

FIRE POLICE OATH OF OFFICE - Carley Ellinger was sworn to serve as a member of Tylersport Fire Police.

2016 FINANCIAL AUDIT – the draft FY16 financial statements were presented in PDF format to both BOS and Finance Committee. Finance Committee review in depth with auditors at their June 13 meeting. Auditor Greg Ede (Styer & Associates) highlighted areas of the audit, management discussion and analysis and noted improvement in the signification deficiencies from prior year. **Motion 17-084** by Styer, second by Lynch approved the FY16 Financial Audit.
