PUBLIC COMMENT:

Barb Lynch commented on road conditions due to turnpike construction; S. Dietz Mill Road is being paved this week. Whites Mill Road conditions are unsafe – Doug Hedrick to follow up in writing to PennDOT regarding repairs.

APPROVAL OF ACCOUNTS PAYABLE INVOICES & INTER-FUND TRANSFERS - Motion 18-089 by Lynch, second by Myers - motion carried 3 - 0.

- **A. RESOLUTION 18-1806** the Montgomery County grant for acquisition of Whites Mill Road properties was not received. - **B. Park Pavillion Roof** Contractor left samples of shingle colors for pavilion roof. Consensus of BOS was to inquire with contractor to cost difference of installing a metal roof versus shingle roof. Karen will email both township engineer and contractor for final consideration at June 20th meeting.
- **C. SWING SETS** Jim Myers offered to pick the swing sets up from the Lewisburg location to save \$300 shipping cost.
- **D. KLINGERMAN ROAD CULVERT** Jim Myers spoke with Jessica Buck (MCCD). This project is too late for consideration in this year's budget Doug Hedrick to contact MCCD for inclusion in 2019 budget.
