New Business:

A. COMPREHENSIVE PLAN REVIEW PRESENTATIONS - Representatives from Montgomery County Planning Commission (Eric Jarrell, Matt Schelly, and Dulcie Flaharty) were present. Matt Schelly explained the Montgomery County Planning Commission contract services; both the current and new County comprehensive plans. Publications - Montgomery County Today and Montco 2040: A Shared Vision are available on line at www.planning.montcopa.org. Eric Jarrell reviewed the Indian Valley Regional Comprehensive Plan and how it began among the surrounding Indian Valley municipalities.

Jeannine Harrell inquired about data from Montgomery County Community College relative to the Indian Valley Regional Comp Plan and also questioned incentive on fossil fuels.

Ed Odenwald commented on County involvement with local industrial companies.

Barb McMonagle commented on recent zoning changes restricting billboards.

B. MOYER FARM - Montgomery County Farm Board has chosen the Moyer Farm (Hunsberger Road) as a priority for farmland preservation and recommends a commitment of Township funds for an agricultural conservation easement on this property. Motion 15-047 by Styer, second by Lynch approved Resolution 15-1727 granting a commitment of \$80,600 funding to preserve Moyer Farm - if accepted, funds would be distributed in 2016. Motion carried 3 - 0.

OLD BUSINESS:

A. ORDINANCE #169 - Following advertisement, proposed Ordinance #169 authorizing participation in PA Townships Health Insurance Cooperative Trust pursuant to the PA Intergovernmental Law. <u>Motion 15-048</u> by Styer, second by Neff approved Ordinance as requested by PSATS. Motion carried 3 - 0.

Barb McMonagle commented on June 3rd agenda items.

Jim Styer questioned the summer meeting schedule – there being no objections, the BOS will meeting once a month (2nd meeting) for the months of June, July and August. Jeannine Harrell asked if the BOS would consider posting the agenda 1 week prior to the meeting.
