## **Public Comment:**

Township Library representative Beth Styer provided an end of year update on Indian Valley Public Library.

**APPROVAL OF NOVEMBER 1**<sup>ST</sup> **MINUTES - Motion 17-150** by Styer, second by Baker - motion carried 3 – 0.

**APPROVAL OF ACCOUNTS PAYABLE INVOICES & INTER-FUND TRANSFERS** – Jim Styer commented on many Boileau invoices. Barb Lynch questioned using Boileau for street sweeping services. **Motion 17-151** by Styer, second by Baker – motion carried 3 – 0.

**APPROVAL OF OCTOBER FINANCIAL REPORT - Motion 17-152** by Lynch, second by Styer - motion carried 3 - 0.

**APPROVAL OF OCTOBER BANK RECONCILIATIONS - Motion 17-153** by Styer, second by Lynch - motion carried 3 - 0.

**APPROVAL OF COMMITTEE AND STAFF REPORTS** – Jim Styer questioned amount of zoning hours by both Office Administration and Zoning Officers. **Motion 17-154** by Lynch, second by Styer – motion carried 3-0.

### **OLD BUSINESS:**

**A. 2018 PRELIMINARY BUDGET(s)** – Jim Styer reported on overall budget and percentage of budget dedicated towards road maintenance. 431 expense category (Ditches) was discussed with regard to MCCD reimbursement. BOS decided to add \$20,000 to revenue category. **Motion 17-155** by Styer, second by Lynch approved Resolution 17-1792 authorizing advertisement of preliminary 2018 Budget. Motion carried 3 – 0.

**B. FIRE ARM DISCHARGE** - Solicitor Steve Imms provided samples of related ordinances throughout the State and reminded the BOS that municipalities cannot regulate anything that the State already regulates. Charles Greaser (Fretz Road) reported on a recent outside event in which they were bothered by loud gun noise, later they discovered bullet debris and damage on their property. Mr. Greaser added they are uncomfortable with enjoying their back yard. BOS will review all ordinance examples provided by Solicitor for further review at December work session meeting.

# **NEW BUSINESS:**

- **A. PLANNING COMMISSION APPOINTMENT** Barb McMonagle reported on Ray Moyer's knowledge with regard to zoning and subdivision processes; and added he would be a great contributor to PC. **Motion 17-156** by Lynch, second by Styer appointing Ray Moyer to fill Freeborn vacancy on Planning Commission. Motion carried 3 0.
- **B.** QUARTERLY SEWER DELINQUENCIES Motion 17-157 by Lynch, second by Styer authorizing Solicitor to send letters to sewer customers greater than 90 days delinquent. Motion carried 3-0.

## **PUBLIC COMMENT:**

Barb McMonagle commented on next joint meeting of BOS and PC with regard to Impervious Coverage Ordinance.

Frank Jarrett commented on remedies to impervious surface.
