A. INDIAN VALLEY LIBRARY UPDATE - Beth Styer and Alex Grande provided an update on the library. Salford Township has greater than 50% resident participation. The strategic planning process for moving forward was discussed.

- **B. MULTI-MODAL GRANT (HAUSMAN ROAD BRIDGE)** Gilmore & Associates processed grant funding application to replace bridge; BOS agreed the township portion (30%) is too extensive at this point. Will be re-visited in 2019. Resolution 18-1810 is voided.
