JOINT MEETING WITH PLANNING COMMISSION – Members present were: Barb McMonagle, Curt Klingerman, Daniel Harrell and Ray Moyer. Topics discussed were revisions to impervious coverage ordinance and SD/LD Ordinance relating to flag lots.

APPROVAL OF JANUARY 16^{TH} MINUTES - Motion 19-029 by Baker, second by Myers - motion carried 3-0.

APPROVAL OF ACCOUNTS PAYABLE INVOICES & INTER-FUND TRANSFERS - Motion 19-030 by Lynch, second by Myers - motion carried 3 - 0.

OLD BUSINESS:

- **A.** MUNICIPAY Motion 19-031 by Lynch, second by Myers approved setting up MuniciPAY allowing public sewer customers to pay electronically. Motion carried 3 0. Township website will be updated and notices will be added to the 2Q2019 invoice mailing.
- **B. DIDOMIZIO PROPERTIES** Barb McMonagle reported on three (3) upcoming grant opportunities with Montgomery County, DCNR and DCED. Open Space Committee is requesting the BOS approve re-submitting grant applications and pledge township funds to acquire the 2 lot tract adjoining Whites Mill. **Motion 19-032** by Lynch, second by Myers approving grant applications contingent upon June DiDomizio commitment match. Motion carried 3 0.

New Business:

A. PUBLIC SEWER CONNECTION - Ken Clemmer (82 N Allentown Road) reported on the MCHD field report and septic inspection - the existing on lot system is failed. Curt Klingerman advised this is an under-sized non-conforming lot and suggested alternative options of getting public sewer to the property such as boring in the right of way. Motion 19-033 by Lynch, second by Baker and Myers authorizing public sewer connection to this property. Motion carried 3 - 0. Mr. Clemmer was made aware of the costs associated with tying into the public sewer.

Doug Hedrick reported the S. Schultz Road (Toro) culvert is completed – paving will be completed by Salford Township.
