A. SEWER DELINQUENCIES – an update of the significant delinquencies was provided. Solicitor advised the notice of intent to terminate water shut off was mailed with an effective date of March 18, 2022. Property to be posted Friday, February 18th. Following administrative process of reminders and late fee assessment, Solicitor letters at >90 days and Shut Off procedure started at

>120 days. Notice of procedure to be inserted with 2^{nd} Quarter billing invoices. Motion 22-037 by Lynch, second by Yothers executing Water Shut Off Agreement with NPWA. Motion passed 3 – 0.

NEW BUSINESS:

A. TRAFFIC LIGHT GRANT OPPORTUNITIES – grant opportunities for modernization of existing traffic light were reviewed both with early 2022 deadlines. Motion 22-038 by Lynch, second by Myers and Yothers approving Resolution 22-1869 requesting Statewide Local Share Assessment Grant to be used for modernization of the existing traffic signal at Ridge and Allentown Road intersection. Motion passed 3 – 0. Township Engineer to provide a design cost estimate for project to be considered "shovel ready".

Barb McMonagle inquired about the status of both Hausman and King Road bridges. She also inquired about the status of Small Cell Wireless Ordinance.

Mike Heiser inquired about livestock rules.
